
The Bridge Builder

Don't Let A Tax Cap Become a Learning Cap

new school year always gives me hope for the future. It also brings new challenges.

The district will face
new fiscal challenges
now that New York State
has passed a tax cap.
The tax levy is capped
at a zero percent

increase unless more than 50 percent of the voters cast a ballot for an increase. It can only increase more than two percent, or the Consumer Price Index (whichever is lower), if 60 percent of the voters vote "yes".

We all support lower taxes, but the State legislature and the governor have passed and signed this legislation without mandate relief. School districts are required to fulfill over one hundred mandates that cost millions of dollars. A tax cap without mandate relief will require difficult decisions about our educational program.

How will this tax cap affect our students? Our school district offers a rewarding, academically rigorous educational program that supports students' intellectual, social and emotional growth. Our elementary school students learn to prevent bullying by forming "Caring Majority" clubs in each school. Middle school students create community during team spirit week and through fundraising activities all year long. High school seniors mentor freshman through our GEM program and have the opportunity to take life-saving courses for certification in CPR/AED. Teachers in all schools mentor "at risk" students through the AIM program. This list does not include the art shows, musical performances, theatrical events, as well as the 65 sports teams and dozens of clubs that promote students' learning

Objective 1: To continue to explore, evaluate, and promote the use of effective technologies to enhance student learning, including SMARTboard technology, Moodle, CPS clickers, as well as other programs and technologies.

Objective 2: To upgrade all computer labs in the district to state of the art machines to enable greater and more potent use of technology in the classroom and to explore the use of virtual desktops to enhance storage capacity, speed and access for students and staff.

GOAL 5: To ensure that our facilities are adequate to meet the needs of all students.

Objective 1: To continue to monitor all capital construction projects.

Objective 2: To continue to provide all stakeholders with timely and appropriate information about the initiation and ongoing progress of all capital projects.
